We oversee collaborations and projects of 100-150 faculty members and 20-30 graduate students annually; offer 10 internal grants programs including a major annual humanities symposium; lead nationally recognized graduate program; host occasional graduate courses and working symposia; and co-sponsor events with campus and community partners. We energetically recruit faculty and students of color into our programs and are seen on campus as a strong ally for colleagues from underrepresented groups. The Center organizes and incubates collaborations and acts as campus liaison for national organizations and collaborations. I have administrative, supervisory, and budgetary responsibilities. I supervise 3 staff members as well as postdoctoral fellows, graduate assistants, and undergraduates, and report to the Vice President for Research.
